### News from Chinesedrywall.com:

Over 2,100 people joined the Knauf Omnibus Complaint filed last week which demands, among other things, that Knauf Plasterboard Tianjin ("KPT") buy back or rescind the contracts for tainted homes or remediate, repair and/or replace the drywall.

Many people missed the deadline. Indeed, many people still do not know that they have Chinese drywall.

Today, the Plaintiffs Steering Committee for the Multi District Litigation ("MDL") announced that it is going to file three more Omnibus Complaints:

- 1) One for those people who missed the original deadline against KPT;
- 2) One for all non-KPT manufacturers of drywall; and
- 3) One for all unknown manufacturers of drywall.

**The deadline to submit a claim for all three Omnibus Complaints is January 15, 2010.**

This is great news for anyone who missed the original deadline and for those who have drywall manufactured by someone other than KPT. Please help spread the word, particularly to those who are part-time residents and may not realize that they have Chinese drywall.
